WHEREAS, the Fairfield Board of Education, in partnership with the Coalition For A Safe and Drug-Free Fairfield, encourages residents to refuse to provide alcoholic beverages to underage youth and to take the necessary steps to discourage this illegal and unhealthy practice, including the reporting of underage drinking, by calling their local police.
