#### ITEMS FOR BOARD DISCUSSION

A. Update on "Race to the Top" – Roger Martin

In reference to Area A, *Standards and Assessments*, Mr. Martin reported that Professional Development for September & November were devoted to effective instruction through the Marzano book study. October focused on building an awareness of the new/revised standards, and December will build on October's presentation with a focus on rigor in the classroom.

He stated that the Fairfield School District was invited to participate in a formative instructional practices (FIP) pilot. Three groups of teachers have volunteered to be part of this pilot. They are reviewing the FIP Professional Development modules for the Department of Education.

In regards to Area C, *Using Data to Improve Instruction*, the district's Value-Added Leaders and building administrators have set the dates to train the Building Leadership Teams on the utilization of Value-Added reports. Ohio Principals Evaluation System Administrator Job descriptions have been aligned to professional standards.

In regards to Area D, *Great Teachers & Leaders*, committee members of the Ohio Principals Evaluation System and the Ohio Teachers Evaluation System have been meeting meetings have been held to align administrative job descriptions to Professional Standards. In addition, the committee members designed the Goal Setting Form. The committee designed a working conditions survey to collect and analyze. An exit survey for staff is being used.
